FEES FOR 2010

THE FEES BELOW ARE PER MARKET DAY

ALL VENDORS: \$25.00 for 10x10 stall plus 6% of daily sales. Single space \$25.00 + 6% of sales
Double space \$50.00 + 6% of sales

Food vendor rules:

Must pay the booth fee for the season* (\$25.00 x 25 weeks = \$625.00) At end of each market day, the 6% sales fee will be collected.

If the vendor has another event, and will be gone from the market, a two week notice must be given.

Please try hard to be there every Saturday. Restaurants do not just leave a location. They are always expected to be there.

*Non-refundable

All vendors must read and sign a copy of the Rules and Regulations (Available on web site)

PLEASE SEND IN PAYMENT WITH APPLICATION

PAYMENT OPTIONS: Pay for the entire season and get a discount: (booth fee only, 6% still due each day)
Pay by February 15th, 2010 get a 10% discount
Pay by March 15th, get a 5% discount
OR
Send in \$100.00 deposit to secure a spot

YOU MUST OBTAIN PERMITS 3 WEEKS BEFORE THE STARTING DATE. BEFORE GETTING YOUR HEALTH DEPARTMENT PERMIT, YOU MUST FIRST BE ACCEPTED BY THE MARKET MANAGER. PLEASE TALK TO THE MARKET MANAGER TO MAKE SURE THERE IS A SPOT FOR YOU. Market Manager has the right to accept or not accept certain food items and vendors.

PLEASE INCLUDE A COPY OF YOUR PERMITS, BUSINESS LICENSES AND INSURANCE COVERAGE
